 - iv. Libraries, reading rooms, recreation centers, centers or institutes for promotion of extra curricular activities, skills, talents or developing a scientific temper.
 - v. Other schools, institutions, centers, training centers, guidance centers, employments bureaus, related to imparting, dissemination of knowledge to any person, group of persons, disassociation or class of persons, leading to award of degrees, diplomas and certificates or otherwise, either free of cost or otherwise.

- 6.4 Board may appoint one of the trustees as Managing Trustee to look after day to day affairs of the Trust subject to the terms and conditions as may be fixed by the Board from time to time.
- 6.5 The Board may co-opt any additional members either in their individual capacity or as ex-officio members of any institution/company/organisation/trust/firm/other entity with which the trust has entered into any arrangement.
- 6.6 The term of office of Co-opted members, who are representatives of institutions etc., as aforesaid with which the Society has an arrangement or tie up, shall be until such time that the arrangement subsists unless decided otherwise by the Board.

- 6.7 Any Co-opted member of the the Board hereby constituted or appointed as provided in this Deed shall die or become bankrupt, insolvent or mentally incapacitated or leave station for more than six consecutive months or refuse or become unfit or incapable to act, then and in every such case, such member shall be deemed to have vacated his office.
- 6.8 The number of Trustees of the said Trust shall not be at any time be less than 2 (Two) or more than 11 (Eleven)
- 6.9 Trust may remove any of the Co-opted trustees before expiry of their term if it is of the opinion that Co-opted trustees have indulged into any of the activities against the interest of the trust. Majority decision of the Board shall prevail in the matter.

7 TRUST PROPERTY :

The term "Trust Property" shall mean the whole or any part of the aforesaid moveable property, all additions and accretions thereto, the income thereof, the acquisitions therewith, the rights and privileges acquired, the conversion thereto in any other form, and all other property movable or immovable , which may from time to time vest in, or come from any source to the Trust.

8 POWERS, RIGHTS, DUTIES AND RESPONSIBILITIES OF THE TRUSTEES:

The Trustees shall stand and be possessed of the Trust and all additions to the Trust Fund and all income arising therefrom upon the Trust and subject to their powers, rights, duties and responsibilities herein below declared concerning the same.

- 8.2 No portion of the income and property of the Trust shall be paid or transferred, directly or indirectly, by way of dividends, bonus or otherwise, however, by way of profits to any person/persons, who at any time are, or have been trustees or to any of them or to any person claiming through them, or any of them provided that nothing herein contained shall prevent the payment in good faith of remuneration to any trustee or any person in return for any service rendered to the Trust.
- 8.3 The official year of the Trust shall be from 1st April to 31st March of each year.
- 8.4 The Trustees shall cause to be maintained proper books of accounts, of the Trust as required by the Act and shall have the accounts audited by a duly qualified Chartered Accountant annually to be appointed by the trustees at a remuneration to be fixed by the members.
- 8.5 The Auditors shall prepare a balance sheet at the end of every financial year and submit a report showing the state of financial affairs of the Trust.
- 8.6 The Auditors shall also prepare Income and Expenditure Accounts of the activities and projects run by the Trust at different places and of different institutions separately and those accounts shall be incorporated in the accounts of the Trust.

- 8.7 The funds of the Trust shall be invested in the modes specified under the provisions of the Income Tax Act 1961 as amended from time to time.

- 8.11 To accept transfer of any movable or immovable property on behalf of the trust and to appropriate, exchange, lease out, rent out, alienate, sell or in any other manner dispose off all or any of it assets or property, with concurrence and approval of the Board.
- 8.12 To institute and/or defend any suit, civil or revenue proceeding, criminal case, or complaint or a legal action of any description whatsoever.
- 8.13 To exercise such other powers not otherwise provided for and to perform such other duties as may be necessary for the proper functioning of the Trust;

- 8.14 To appoint eminent persons who are experts in specific fields to constitute Managing Committees or such other committees, and Sub-Committees and delegate such powers to advise and manage the functioning of specific projects or groups of projects commensurate with the objectives of the trust.
- 8.15 To retain, appoint, promote, dismiss any employees for Managing and functioning of the trust and to regulate their terms and conditions of employment including remuneration.
- 8.16 For carrying out the objects, the Trustees may engage in and carry on business or businesses for and on account of the Trust established by this Deed and may invest any part of the fund or assets of the Trust. In the course of such business the Trustee may do all that necessary for carrying on such business or businesses. They may sign contracts, open Bank Accounts, sign Cheques, negotiate documents, institute legal proceedings, and do all that is necessary for the successful carrying on of the business or businesses and execution of the Trust. For convenience and easy management, Trustees may delegate any power/s vested in them to one or more Trustess or to one or more officials/representatives of the Trust subject to such conditions as they deem fit to impose to achieve the objectives of the Trust.
- 8.17 The Trustees shall have the authority to deposit the securities or investments of the Trust with the Bankers for safe custody and collection of interest, dividend, etc. and also to deposit the Trust Fund in any Bank Account opened in the name of the Trust .

8.18 Without prejudice to the foregoing, the Trustees shall have power to do the following :-

- To sell any or portion of any property forming part of the Trust Fund at such prices and on such terms and conditions as they think fit and proper;
- To let or lease any portion of any immovable property forming part of the Trust at such rent or compensation for such periods and on such terms and conditions they may think fit and proper to accept surrender of any lease, and to file suits in ejectment and/or for recovery of rents and other dues.
- To open and maintain Bank Accounts in the name of the Trust, and to close the same; Operation of the Bank Account may be delegated by the Board to such of the Trustees or Officers of the Trust as the Board deems fit subject to the conditions and restrictions to be imposed by the Board from time to time.

8.19 It shall be lawful for the Trustees for the time being of these presents to reimburse themselves, himself or herself or pay and discharge out of the Trust properties all costs, charges and expenses incurred in carrying out of these presents or in or about the execution of the Trust or powers of these presents.

- 8.20 The acknowledgment by the Trustees for the purchase moneys of any property hereby authorised to be sold or for any other moneys paid or for any shares, stocks, funds or securities transferred to them shall effectively discharge the person or persons paying or transferring the same, therefrom and from being bound to see the application or being answerable for the loss or misappropriation thereof, if any.

- 8.23 If Trustees hereby constituted or any of them, or Trustees appointed as provided in this Deed shall die or becomes bankrupt, insolvent or mentally incapacitated, such Trustee shall cease to be a Trustee of these Trusts, and shall cease to exercise any powers recited in clause hereinabove. Similarly, Trustee who has attained the age of 75 years shall automatically stand discharged from Trusteeship.

8.29 The Trustees may dissolve the Trust by a unanimous decision in writing after transferring the assets of the Trust to any one or more person or persons or body or bodies, provided the Trustees ensure that the assets so transferred shall be used only for the objects of the Trust of these presents. 9 TRUST NOT TO FAIL :

The objects and other provisions of the Trust have been framed and laid down in accordance with the law so that this Trust shall never fail. But if at any time the Trustees find or come to know that any particular provision hereof is invalid or contrary to the law, it shall be their duty to cancel and treat the same as cancelled, so that the other provisions hereof may not be rendered invalid or otherwise affected.

10 INTERPRETATION :

The trustees shall have full power to compromise all differences and disputes touching the trust's property and/or trust's estate to refer any such differences or disputes to arbitration and to adjust and settle all accounts relating to the trust's property and/or the trust's estate and to do all other acts, deeds and things as fully and effectively being liable for any occasioned thereby. The trustees shall have full power to refer differences or disputes between them inter-se touching the affairs of the trust to arbitration under the provisions of Arbitration and Reconciliation Act. Place of arbitration shall be at Bangalore for all dispute adjudication.
